

Update 3/15:

Question(s) regarding computer access:

Student Question: My family has a reliable computer, but I need to share this device with my siblings and parents. How will this impact my ability to engage with online activities?

Answer: We understand that many students will face challenges such as this and other difficulties related to computer and internet access. The simple answer is - do your best! Obviously, if a teacher conducts a live activity (Hangout, etc.), not all students we be able to participate in every instance. Your teachers understand this. Use your home resources (including your phone!) to the best of your ability, and communicate concerns with your teachers through Classroom or email.

1. Instructional Blocks:

In order to help students organize their time, and to prevent multiple online activities from conflicting with one another, we will be using a modified “**Home Instruction Schedule.**” This modified schedule spreads out instructional sessions, fulfills the NJDOE requirement for four hours of instruction and will help organize live online engagement.

Update 3/14: EXPECTATIONS during Hours of Instruction:

- Students are expected to be engaged with their academic work during the hours of the Home Instruction Schedule.
- An ideal time to communicate with specific teachers, whether through email or Classroom, etc., is during the specific time your class with that teacher is scheduled.
- As is typically the case, students need to study and complete assignments outside their scheduled class time. This expectation remains when we use the Home Instruction Schedule.
- If teachers facilitate a live event (Hangout, Kahoot, live chat on Docs, etc.) students should be engaged. If access to necessary technology prohibits students from being able to participate, they should attempt to email their teacher to communicate this.

2. Daily Attendance - Essential Question:

The administration is creating one, school-wide Google Classroom for all students, Within this Classroom students will be required to answer an **Essential Question** each day. Responses to this question will provide evidence that students engaged with home instruction on a day when we were physically closed. Answering this question is mandatory and it will be one piece of evidence used to substantiate student attendance.

Update 3/14: All students are required to post a response to the daily *Essential Question* by 12:00 p.m. each school day.



3. Trips and Extra-Curricular Activities:

Update 3/14: All athletic (practices and competitions) and extracurricular activities schedule to take place have been suspended.

For now, we will continue to evaluate each event on a case by case basis.

4. Food Distribution:

Update 3/14: High Point will be distributing “bagged” lunches to eligible students in the front on the main entrance to the high school on the following days/times:

Each day on which lunches are distributed, students or parents may pick up lunches for multiple days, possibly as many as four lunches per qualifying student. We will determine this based upon availability.
